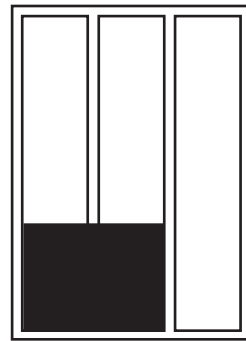

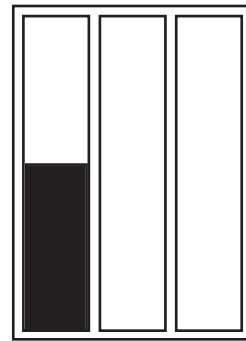

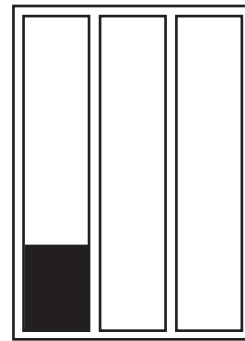

ADDITIONAL DIGITAL FILE INFORMATION

- Ads that are black ink: artwork must not contain RGB, CMYK or spot-color elements.
