# Buffalo Lawyers and Community Partners Will Celebrate the 70th Anniversary of Brown v. Board of Education, the Historic 1954 U.S. Supreme Court Case Holding State Sanctioned School Segregation Unconstitutional

**April 25, 2024** – A coalition of organizations has come together to present *Brown v. Board in Buffalo: A 70th Anniversary Celebration* at the Historic DeLaine Waring AME Church, on Friday May 17, 2024, from 2:00pm to 6:00pm. This celebratory community event will highlight the historical connection between the Brown decision and the DeLaine Waring Church on Swan Street. The DeLaine Waring congregation will host the program featuring civil rights scholars, church leaders and the Chief Administrative Judge of the 8th Judicial District. Pastor Earl Perrin, Jr., of DeLaine Waring AME Church, "welcomes all and encourages Buffalonians to come out and learn more about his church's important connection to one of the most impactful civil rights cases of the 20th Century, including his congregants sharing their lived experiences in nonintegrated schools prior to Brown."

The Speakers include the Hon. Kevin M. Carter, Administrative Judge, New York State Unified Court System Eighth Judicial District; Joseph A. DeLaine, Jr.; Professor Roy I. Jones, Ed.D., Clemson University; Pastor Earl Perrin, Jr., DeLaine Waring AME Church, and Richard T. Sullivan, Esq., Author, Buffalo's Monument to Civil Rights.

## About Buffalo, the Church & Brown v. Board of Education

The DeLaine Waring AME Church in Larkinville is named after the Rev. J.A. DeLaine, a Black educator, parent, minister, civil rights advocate and plaintiff in the Briggs v. Elliott case, a companion case that was litigated with Brown. Court. The Church is also named after Judge J. Waties Waring, a white federal judge who helped push for the US Supreme Court to address school segregation.

The Rev. DeLaine's son, Joseph A. DeLaine, Jr., and Dr. Roy I. Jones, professor of education at Clemson University, will speak about the history of the civil rights cases Briggs v. Elliott and Brown v. Board, and the church itself. They will be joined by Hon. Kevin M. Carter, Administrative Judge for New York State's

Eight Judicial District, Rev. Earl Perrin of DeLaine Waring AME Church, and attorney Richard T. Sullivan, author of the paper Buffalo's Monument to Civil Rights.
